MAJOR PROJECTS UNDERWAY:

- **US 290:** reconstruction and widening from I-610 to FM 2920 – \$2.4 billion
 - Anticipated completion: 2018
- **SH 288 toll lanes in Harris County:** construct 4 toll lanes from US 59 to Harris/Brazoria County line. Comprehensive Development Agreement for \$815 million.
 - Construction began October 2016
 - Anticipated completion: Late 2018
- **I-45 South:** widening from Nyack to FM 2351 – \$77 million
 - Anticipated completion: Summer 2017
- **I-45 South:** widening from El Dorado to Medical Center Drive – \$93 million
 - Anticipated completion: Fall 2018
- **US 59/I-69S:** widening from FM 762 to Spur 10 – \$135 million
 - Anticipated completion: 2018

PLANNED MAJOR PROJECTS:

- **US 59/I-610 West Loop interchange reconstruction*:** estimated cost \$287 million
 - Anticipated letting: Summer 2017 with completion targeted for Spring 2021
- **I-45 South*:** Nasa Road 1 to FM 518; estimated project cost \$132 million
 - Anticipated letting: Spring 2017 with completion targeted for Summer 2022
- **I-10 West*:** FM 359 to Brazos River; estimated project cost \$242 million
 - Anticipated letting: Summer 2017 with completion targeted for Spring 2021
- **SH 99/Grand Parkway Segments H and I:** design-build contract to construct 6.5 miles of new toll lanes; estimated cost \$1.1 billion
 - Conditional award and start of construction anticipated in FY 2017
- **SH 249 in Montgomery County and Grimes County:** estimated cost \$400 million
 - Conditional award and start of construction anticipated in FY 2017
- **I-45 North:** from downtown to Beltway 8
 - Currently in environmental impact statement phase; anticipating clearance in FY 2018

MAINTENANCE: The district spent \$120 million in FY 2016 on preventive and routine maintenance.

CORRIDORS: The district's major thoroughfares include I-610 Loop, I-10, I-45, SH 288, SH 6, SH 225, SH 146, US 59/I-69, US 290, US 90 and Beltway 8.

SAFETY: \$5 million allocated for traffic signal, shoulder and striping improvements for fiscal year 2016.
