## Barbours Cut Channel Deepened

The completion of the deepening and widening of the Barbours Cut Channel was announced at the Port of Houston Authority Port Commission meeting on September 29, 2015. The Houston Pilots have given authorization to the Port of Houston to receive vessels with a 45 ft. operating depth, up from 40 ft. The MSC Oriane became the first ship to take advantage of the deeper channel.

Port Commission Chairman Janiece Longoria remarked, "The increased vessel operating depth at 45 feet will significantly improve efficiency of ships calling at Barbours Cut and opens the door for future classes of larger ships to call." The improvements to the Barbours Cut Channel is expected to result in over \$900 million in economic benefits over the next fifty years.

Sixty-seven percent of all containerized cargo on the Gulf Coast is handled by the Port of Houston. Over the last year, container volume has increased by 17 percent. Barbours Cut is Houston's busiest of two container terminals. Dredging at Bayport, Port of Houston's second container terminal, will finish next year.

The channel improvements will allow the Port of Houston to accept post-Panamax container vessels. In May of this year, the Port of Houston received four post-Panamax cranes at Barbours Cut capable of unloading ships 22 containers wide. The Port of Houston also plans to improve the capacity of its container yard. The port anticipates a doubling of terminal capacity following the completion of all improvements at Barbours Cut.

## Port of Galveston Celebrates 15 Years of Cruising

The Port of Galveston recently celebrated a major milestone as a leader in the cruise industry. September 30, 2015 marked 15 years of year-round cruise service through Galveston.

Mike Mierzwa, the Port Director for Galveston, said, "We celebrate the positive impact the cruise industry has had on our community. It is important that we recognize that not only is this business great for Galveston, but also for the entire state of Texas." The cruise industry in Galveston has generated \$1.2 billion in direct spending and 20,000 jobs paying nearly \$1.1 billion in income.



Since 2000, the port has invested \$85 million in its cruise facilities to continue providing great service. The port is currently investing \$13 million to expand its second cruise terminal, expected to be complete by March

2017. Through the years, the Port of Galveston has had more than 2,600 ship calls, hosted 18 different cruise ships, and served over 7 million passengers. Galveston is an increasingly popular homeport for cruisers. More than 824,000 passengers are expected to sail through Galveston in 2015, a 28 percent increase from 2014. Galveston is currently the 4th busiest cruise port in the U.S.

The Port of Galveston is home to Carnival and Royal Caribbean Cruise Lines. Disney Cruise Lines will return to Galveston for the 2015 holiday season.

## Ribbon Cutting Ceremony at Port of Brownsville for Dock 16

On August 7, 2015, a ribbon cutting ceremony was held at the Port of Brownsville for a new state-of-the-art dock. Dock 16 is Brownsville's second heavy-load capacity dock and can accommodate deep draft cargo vessels. This was the first time in 16 years that Brownsville has opened a new dock.

Dock 16 was funded in part through a \$12 million Department of Transportation TIGER grant. The port provided the rest of the funding for the construction of the dock. In total, the project cost \$27.5 million. The dock is expected to boost capacity and decrease wait times for cargo vessels.

The ribbon cutting ceremony included the U.S. Maritime Administrator Paul N. Jaenichen and Congressman Filemon Vela, Jr.
