## Laboratories Approved to Perform Compaction and Triaxial Compression Testing

### Overview

The Geotechnical, Soils, and Aggregates Section of the Materials and Tests Division (MTD) maintains a program to qualify commercial laboratories to conduct compaction and triaxial compression testing of soils and base materials. A commercial laboratory is defined as a laboratory that performs testing for contractors, material suppliers, the Department, or any company performing work associated with a Department project. Laboratories approved under this program can:

- conduct compaction and triaxial compression testing of soils and base materials for the Department and
- conduct compaction and triaxial compression testing of soils and base materials for contractors and suppliers to use as a basis of request for referee testing by MTD.

The following commercial laboratories have met the requirements of DMS-7400, “Qualification Procedure for Laboratories Conducting Compaction and Triaxial Compression Testing of Soils and Base Materials,” and are approved to perform Tex-113-E and Tex-117-E.
