The following manufacturers for concrete curing compounds have complied with DMS 4650, “Hydraulic Cement Concrete Curing Materials and Evaporation Retardants.” This Specification describes the procedure for pre-qualification.

These manufacturers are pre-qualified to supply the following products for use on Department projects and requisitions when DMS-4650 is referenced. No further sampling and testing is required unless deemed necessary by the engineer or Materials and Tests Division (MTD). Tex-718-I, “Sampling Liquid Membrane-Forming Compounds for Curing Concrete,” describes the sampling method.

The Department reserves the right to conduct random sampling of prequalified, certified materials for testing and to perform random audits of documentation. Department representatives may sample material from the manufacturing plant, the project site, and the warehouse. The Coating, Calibration, and Traffic Materials (CCTM) Section of the Materials and Tests Division reserves the right to test samples to verify compliance with DMS-4650.

Variation from specified Percent Solids is allowed up to ± 2%.
