4. SH 183 Managed Lanes Project

- ❑ Expanded scope
 - Likely attracts more proposers
 - Maximizes leverage of public funds

- ❑ Commission authorized issuance of an RFQ
 - SH 183 Managed Lanes from SH 121 to IH-35E
 - Connecting facilities (potentially Loop 12 and SH 114)

4. SH 183 Managed Lanes Project



4. SH 183 Managed Lanes Project

□ Phase 1 – (1+1 Managed Lane)

- Adds one managed lane in each direction
- Reconstructs portions of general purpose lanes (no added GP capacity)
- Reconstructs frontage roads and enhances local connectivity

□ Phase 2 – (2+2 Managed Lanes)

- Adds one additional managed lane in each direction
- Reconstructs remainder of general purpose lanes (no added GP capacity)

□ Phase 3 – Ultimate Configuration

- Adds one general purpose lane in each direction (added GP capacity)
- Adds one additional managed lane (3+3) in some locations
- Adds remaining bridges and ramps in the ultimate schematic
- Adds remaining frontage road & cross streets in the ultimate schematic

5. SH 183 Managed Lanes Project

- ❑ CDA Authority
 - Legislative authority required to add SH 114 and Loop 12

- ❑ Primacy
 - NTTA performing due diligence for SH 114 and Loop 12

- ❑ Planning and Environmental
 - Coordinating 2013 Plan Amendment with NCTCOG
 - Coordinating environmental documents with FHWA
