Construction stormwater Best Management Practice must be installed, maintained, and removed in accordance with specific manufacturer specifications, where applicable, and the Construction General Permit (TXR150000).

	<p>DESCRIPTION</p> <p>General material & equipment management addresses the practices associated with proper storage, maintenance, and use of general site materials and equipment at the construction site.</p>																				
<p>APPLICATION</p>																					
<p>General material and equipment management is applicable to all construction sites. The objective of this BMP is to prevent the improper storage and use of material and equipment at the construction site.
