

## NOTICE OF PUBLIC MEETING FM 1810 AT US 81/ US 287 INTERCHANGE FEASIBILITY STUDY - WISE COUNTY

The Texas Department of Transportation (TxDOT) will conduct a Public Meeting on Tuesday, June 17, 2014, from 6 p.m. to 8 p.m., at the Decatur Civic Center, 2010 W. U.S. 380, Decatur, Texas 76234. The purpose of the meeting is to offer an opportunity for the public to discuss and make comments regarding the Farm-to-Market (FM) 1810 at U.S. Highway (US) 81/US 287 Interchange Feasibility Study in the City of Decatur, Wise County, Texas. There will be no formal presentation. The Public Meeting will be an open house format, allowing visitors to come and go at their own availability.

The feasibility study area includes the northwest quadrant of the City of Decatur and begins west of County Road (CR) 1100 along FM 1810 and extends eastward to US 81/US 287. The southern limit of the study area begins south of Business US 380 and extends northward along US 81/US 287 to a point just north of CR 1160. The study is being prepared to identify a long term solution to improve the safety and operations of the FM 1810 at-grade intersection with US 81/US 287. Operational issues identified include better management of the traffic flow, conflicting traffic movements on US 81/US 287 between FM 1810 and US 380, and high truck volumes on FM 1810 and US 81/US 287. Layouts have been developed showing potential improvements that may consist of providing a grade separation at the existing location of FM 1810 at US 81/US 287 or the relocation of FM 1810 to a location further north along US 81/US 287 or southward to connect to US 380.

These layouts reflecting the preliminary alternatives will be displayed at the Public Meeting. TxDOT staff and consulting engineers will be available in an informal setting to answer questions throughout the hours of the open house. They will assist in orientation and interpretation of the drawings and other material on hand, and discuss possible design and environmental effects of the project. Written comments from the public regarding this project are requested through June 27, 2014 and will become part of the project documentation.
