To All Shortlisted Proposers:

The Texas Department of Transportation (TxDOT) is pleased to provide Addendum #5 to the Request for Proposals (RFP) for the Southern Gateway Project to the shortlisted Proposers.

Please note that the only substantive change to the RFP in this Addendum #5 is to conform the pass/fail requirements set forth in ITP Section 5.3.2 for the Preliminary Project Baseline Schedule and ITP Form Q, so that ITP Section 5.3.2 accurately reflects the requirements listed in ITP Form Q and the DBA. No other portion of the RFP has been revised by this Addendum #5, except for revisions to the schedule noting the date of issuance of this Addendum #5, updates to the Addendum number in the footers and clarification in Section 2.3.1 of the ITP that Proposers are not permitted to submit questions for this Addendum #5.
