Those bids and funding increases accepted by the commission will result in conditional contract awards to the low bidders. Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy federal DBE subcontracting requirements, or other requirements as outlined in the project bid proposal.*

- b. **Bicycle and Pedestrian Advisory Committee**  
Consider the appointment of members to the Bicycle and Pedestrian Advisory Committee ([MO](#))  
*The Bicycle and Pedestrian Advisory Committee advises the commission on bicycle and pedestrian issues and matters of mutual concern between the department and the bicycling and pedestrian communities. By involving representatives of the public, including bicyclists, pedestrians, and other interested parties, the department helps ensure effective communication with the bicycling and pedestrian communities, and that the bicyclist's and pedestrian's perspective will be considered in the development of departmental policies related to bicycle use and pedestrian activity, including the design, construction, and maintenance of highways.*
- 116301 c. **Border Trade Advisory Committee**  
Consider the appointment of members to the Border Trade Advisory Committee ([MO](#))  
*This minute order appoints members to the Border Trade Advisory Committee. The purpose of the committee, created in 2001 by the 77th Legislature, is to define and develop a strategy and make recommendations to the commission and the governor, in order to address the highest priority border trade transportation challenges.*

*This minute order approves appointment of members to the Port Authority Advisory Committee to fill vacated terms. The purpose of the committee, created by state law, is to offer advice and recommendations that will provide the commission and the department with a broad perspective regarding maritime ports and transportation-related matters to be considered in formulating department policies concerning the Texas maritime port system.*

*This minute order adopts the department's annual budget as prescribed by the General Appropriations Act.*

Consider the adoption of the Texas Department of Transportation's Fiscal Year 2024-2025 Legislative Appropriations Request ([MO](#)) ([Presentation](#))  
*Every two years the department is required to submit a Legislative Appropriations Request (LAR) for the upcoming biennium to be considered by the Texas Legislature. The proposed LAR describes the level of funding, method of finance, and full time equivalents associated with the department's strategies for the fiscal year 2024-2025 biennium. State law requires the department to deliver the LAR to the commission in an open meeting not later than the 30th day before the date the department submits the LAR to the Legislative Budget Board and the Governor's Office.*
- 116305 11. **Design-Build Contract**  
**Bexar County - I-35 Northeast Expansion (NEX) South Project** Consider authorizing the department to issue a request for proposals to design, construct and maintain the I-35 NEX South Project, consisting of non-tolled improvements along I-35 from approximately I-410 South to I-410 North, including transitions along I-35 from Petroleum Drive to I-410 South, and along the portion of I-410 South from the I-35/I-410 South Interchange to 0.3 miles north of Seguin Road/FM 78, in San Antonio and Bexar County; and consider approving stipulated amounts as payment for the work product of unsuccessful proposers ([MO](#)) ([Presentation](#))  
*On March 31, 2022, in Minute Order 116217, the commission authorized the department to issue a request for qualifications to design, construct and potentially maintain the I-35 NEX South Project. This minute order continues the procurement process by authorizing the issuance of a request for proposals for the project and approves stipulated amounts for the payment of work product of responsive, unsuccessful proposers.*

**Bexar County** - FM 1560 - Consider rescinding Minute Order 114167, dated December 18, 2014 ([MO](#))  
*Under Minute Order 114167 the commission recommended that a portion of FM 1560 be removed from the state highway system and transferred to the City of San Antonio subject to its continued use for public road purposes on the issuance of the Project Acceptance Letter for project CSJ 2230-01-013. A Project Acceptance Letter has not been issued. Because the commission has now determined that the property continues to be needed for state highway purposes, this minute order rescinds Minute Order 114167.*
- 116307 13. **Eminent Domain Proceedings**  
**Various Counties** - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) ([MO](#))  
*Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18, 82nd Legislature, to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.*

*The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.*
- 116312 (4) **Harris County** - I-610 - Consider the exchange of right of way as part of a transaction to acquire real property needed for a state highway purpose ([MO](#))  
*The district has determined that the land to be conveyed by the State in the exchange is no longer needed for a state highway purpose. The governor, on the recommendation of the commission, may execute a deed exchanging an interest in real property acquired but not needed for a highway purpose as whole or partial consideration for another interest in real property needed for a state highway purpose.*
- 116313 (5) **Liberty County** - SH 146 - Consider the sale of right of way to an abutting landowner ([MO](#))  
*The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.*
- 116314 (6) **Rockwall County** - SH 276 - Consider the sale of right of way to the City of Rockwall, Texas ([MO](#))  
*The district has determined that the land is no longer needed for highway purposes. The City of Rockwall has requested to purchase the land, and it may be sold to the city.*
- 116315 (7) **Wharton County** - US 59 - Consider conveyances to the City of Wharton for the construction, operation, and maintenance of a flood control project in cooperation with the United States ([MO](#))  
*In connection with the Lower Colorado River Basin Phase I, Texas, Wharton Flood Risk Management Project, TxDOT proposes to convey a fee interest, subject to a retained highway easement, to the City of Wharton for the construction of permanent levee improvements which will intersect the existing US 59 right of way. TxDOT also proposes to convey four temporary easements for the purposes of access and construction.*

*State law requires the commission to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*

(2) **Quarterly Investment Report for all of the funds invested at the direction of the commission ([Report](#))**

*This is a presentation of the quarterly investment report for the investment of: (1) funds held by the Bank of New York Mellon, as trustee, under the Indenture of Trust securing the Central Texas Turnpike System toll revenue obligations; (2) funds for the pre-paid TxTag account held by the Bank of New York Mellon, acting as custodian; (3) funds held by Amegy Bank, a Division of ZB, National Association, as trustee, under the Trust Agreement securing the I-35E Managed Lanes Project toll revenue obligations; and (4) funds held by U.S. Bank National Association, as trustee, under the Master Trust Agreement securing the SH 249 System toll revenue obligations.*

*The commission financed a portion of the costs of the system with obligations issued pursuant to a trust agreement. In accordance with Section 709 of the trust agreement, the commission is providing to the trustee, general engineering consultant, and traffic consultant a report of general information regarding the system for the preceding fiscal quarter. A copy of the report is being filed with the Municipal Securities Rulemaking Board through its Electronic Municipal Markets Access System.*

This minute order also rescinds the Derivative Management Policy.*

*This minute order approves the commission's investment policy and investment strategies. *This minute order approves the annual budget of revenues, operating and maintenance expenses, and capital expenditures for the I-35E Managed Lanes Project in Dallas and Denton counties. The commission financed a portion of the costs of the I-35E Project with a TIFIA loan. The trust agreement for the loan stipulates that the commission will adopt an annual budget by the business day preceding the first day of each fiscal year.*
- 116320 (5) **Travis and Williamson Counties** - Consider the approval of the Central Texas Turnpike System annual operating, maintenance and capital budgets ([MO](#))  
*This minute order approves the annual operating, maintenance, and capital budgets for the Central Texas Turnpike System (CTTS) which consists of SH 130 Segments 1-4, SH 45N, SH 45SE, and Loop 1 extension. Some costs of the CTTS were financed with debt obligations. The Indenture of Trust stipulates that the commission will adopt annual budgets by August 31 of the preceding fiscal year.*
- 116321 e. **Land Acquisitions for Facilities**  
**Various Counties** - Consider the grant of authority to the department to acquire real property for facilities ([MO](#))  
*The department is in the process of acquiring real property for the construction of new facilities and the expansion of existing facility sites. Funds for the purchase of these properties were appropriated by the 87th Legislature, Supplemental Appropriations Act for the 2022-23 Biennium. The department requests the commission's authorization to enter into purchase contracts and related documents to complete the acquisition of the listed properties.*
