Texas Delivers 2050 fulfills the federal requirements of the Infrastructure Investment and Jobs Act to develop a performance-based, statewide, multimodal freight plan. The Plan must also include several new elements such as adequacy of commercial motor vehicle parking and rest facilities, supply chain cargo flows, inventory of commercial ports, impacts of e-commerce, and strategies and goals to address impacts of freight movement on the environment.

- 116396 9. **State Infrastructure Bank** ([Presentation](#))
Bell County - City of Nolanville - Consider preliminary approval of a request from the City of Nolanville for a State Infrastructure Bank loan in the amount of up to \$1,000,000 to pay for the costs of bridge repair, road construction, and a shared use path necessary for a non-tolled off-system project to make improvements to Old Nolanville Road and bridge in Bell County, Texas ([MO](#))
City of Nolanville (City) will secure the loan with a pledge of ad-valorem taxes. The loan will be used to pay the City's costs associated with bridge repair, road construction and a shared use path necessary for a non-tolled off-system project to make improvements to Old Nolanville Road and bridge in Bell County, Texas.
- 116397 10. **Project Finance**
Tarrant County - Consider authorizing the Texas Private Activity Bond Surface Transportation Corporation to take all actions necessary for issuing one or more series of bonds and loaning the proceeds to the North Tarrant Express Mobility Partners (developer) to: 1) finance the design and construction costs of the North Tarrant Express ultimate capacity improvement project and related work; and 2) pay the costs of issuance. The department will share in the gains, if any, from the financing, and will be reimbursed its cost of assisting with the financing, in accordance with the terms of the comprehensive development agreement between the department and the developer ([MO](#))
In 2008, the commission created the Texas Private Activity Bond Surface Transportation Corporation (corporation) to assist with the development and financing of transportation facilities. Since 2008, the corporation has completed seven financings totaling almost \$4 billion exclusively for five developers who have each entered into a comprehensive development agreement (CDA) with the department. In 2009, the department and the developer entered into a CDA in which the department required the developer to make certain expansions to the corridor when revenue targets were met. Pursuant to the 2009 CDA, it is expected that the targets will be met by the end of the calendar year thereby requiring the developer to commence with the expansion. The developer has requested that the corporation issue bonds as part of the developer's plan of finance for the required expansion. Under the terms of the CDA between the department and the developer, the developer will pay to the department a percentage of the financing gains, if any, as specified in the CDA, and the department's cost of performing any requested activity in connection with the financing.
In 2005, the Safe, Accountable, Flexible, Efficient Transportation Equity Act (SAFETEA-LU) was signed into law, amending Section 142 of the Internal Revenue Code and adding highway facilities to the types of privately developed and operated projects for which private activity bonds (PABs) may be issued. This change allowed private activity on these types of projects, while maintaining the tax-exempt status of the bonds. The Infrastructure Investment and Jobs Act signed into law in 2021 continued this PABs highway program. The United States Department of Transportation would need to approve a PABs allocation for this financing.
The developer is solely obligated to repay the debt on the bonds and any bonds issued by the corporation do not constitute a debt or liability of, or pledge by, the State of Texas (state), the commission, or the department.
The developer has indicated that the requested financing would provide the most efficient and lowest cost method of financing the required expansion, and the financing is expected to benefit the state, the commission, and the department as it makes it more likely for the department to share not only in potential gains created by the current financing per the terms of the CDA, but also potential gains from any future financings.

116398 Various Counties - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) ([MO](#))
Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18, 82nd Legislature, to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.

State statutes require the commission to acknowledge the acceptance of a gift to the department that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.
- b. **Real Estate Dispositions**
The commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.
- 116400 (1) Dallas County** - SH 114 - Consider the exchange of drainage channel easements as part of a transaction to acquire a drainage channel easement needed for a state highway purpose ([MO](#))
The district has determined that the easement to be released by the State in the exchange is no longer needed for a state highway purpose. The commission may recommend, subject to approval by the attorney general, that the governor execute an instrument exchanging an interest in real property acquired but not needed for a highway purpose as whole or partial consideration for another interest in real property needed for a state highway purpose.
- 116401 (2) Parmer County** - FM 145 - Consider the exchange of right of way easements as part of a transaction to acquire real property needed for a state highway purpose. ([MO](#))
The district has determined that the easements to be released by the State in the exchange are no longer needed for a state highway purpose. If the value of the easements is less than \$10,000, the commission may authorize the executive director to execute an instrument exchanging an interest in real property acquired but not needed for a highway purpose as whole or partial consideration for another interest in real property needed for a state highway purpose.
- 116402 (3) Travis County** - SH 130 - Consider the sale of right of way to an abutting landowner ([MO](#))
The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.

- The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester. The easement may be released to the underlying fee owner.*

- (1) **Compliance Division Report**
- State law requires the commission to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*
- (2) **Grimes and Montgomery Counties** - Quarterly Traffic and Operating Report for the State Highway 249 System ([Report](#))
- The commission financed a portion of the costs of the system with obligations issued pursuant to a trust agreement. In accordance with Section 709 of the trust agreement, the commission is providing to the trustee, general engineering consultant, and traffic consultant a report of general information regarding the system for the preceding fiscal quarter. A copy of the report is being filed with the Municipal Securities Rulemaking Board through its Electronic Municipal Markets Access System.*
- (3) **Environmental Report**
- Consider the acceptance of the report on projects being processed under the procedures of Transportation Code, Chapter 201, Subchapter I-1 ([Report](#))*
- The report identifies projects with a local government sponsor being processed under the environmental review procedures set forth in Transportation Code, Chapter 201, Subchapter I-1. A report must be submitted twice a year to the commission, as required by Transportation Code, §201.762(a).*
- 116404 d. **Speed Zones**
- Various Counties** - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state ([MO](#))
- This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*
