*This minute order authorizes the Texas Department of Transportation to utilize federal formula funds to issue one or more requests for grant applications and award one or more grants to construct electric vehicle charging stations along the Electric - Alternative Fuel Corridors.*

**Hidalgo County** - In and around the city of Donna, consider extending the designation of SH 68 and designating State Spur 81 on the state highway system ([MO](#))  
*This minute order (1) extends the designation of SH 68 on a new location from the intersection of I-2 southward and westward to FM 3072, then westward concurrent with FM 3072 to the proposed 365 Tollway, a distance of approximately 9.4 miles; and (2) designates State Spur 81 on a new location on the state highway system from the intersection of the proposed extension of SH 68 southward and eastward to FM 493, a distance of approximately 3.3 miles.*

*The Unified Transportation Program (UTP) is a 10-year statewide plan for transportation project development. The Project Selection Process (PSP) is approved annually and describes the funding categories and process for selecting transportation projects. This minute order approves funding adjustments for certain fiscal year 2023 projects in the 2023 UTP, the 2024 UTP for fiscal years 2024-2033, and the PSP for the 2024 UTP.*

*The Bicycle and Pedestrian Advisory Committee advises the commission on bicycle and pedestrian issues and matters of mutual concern between the department and the bicycling and pedestrian communities. By involving representatives of the public, including bicyclists, pedestrians, and other interested parties, the department helps ensure effective communication with the bicycling and pedestrian communities, and that the bicyclist's and pedestrian's perspective will be considered in the development of departmental policies related to bicycle use and pedestrian activity, including the design, construction, and maintenance of highways.*

*This minute order appoints members to the Border Trade Advisory Committee. The purpose of the committee, created in 2001 by the 77th Legislature, is to define and develop a strategy and make recommendations to the commission and the governor, in order to address the highest priority border trade transportation challenges.*

*This minute order adopts the department's annual budget as prescribed by the General Appropriations Act.*

*The proposed minute order authorizes a one-time work authorization extension for specific Single-Discipline-Specific Indefinite-Delivery engineering contracts to allow contracts expiring in 2024 to extend to 2026 and contracts expiring in 2025 to 2027. Due to the challenges associated with work and supply disruptions brought about by the Covid pandemic, the Federal Highway Administration has waived the federal contract term requirements that will allow the department to make these extensions. Under 43 TAC §9.32 (b)(1)(B) the extension of these work authorizations requires commission approval.*

*The city of Plainview (city) will secure the loan with a pledge of water and sewer revenues. The loan will be used to pay the city's costs associated with utility relocation necessary for a non-tolled on-system project for improvements on SH 194 in Hale County, Texas.*

*State law requires the commission to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.*

(2) **Grimes and Montgomery Counties**

Fiscal Year 2023 SH 249 System Annual Inspection Report ([Report](#))

*The commission financed a portion of the costs of the system with obligations issued pursuant to a trust agreement. In accordance with Section 504 of the trust agreement, the commission has caused the general engineering consultant to make an inspection of the system at least three months prior to the end of the fiscal year and submit a report to the commission prior to the end of the fiscal year.*

(3) **Dallas and Denton Counties**

Annual Inspection Report for the I-35E Managed Lanes Project ([Report](#))

*The commission financed a portion of the costs of the project through a Transportation Infrastructure Finance and Innovation Act loan evidenced by a note issued pursuant to a trust agreement. In accordance with Section 504 of the trust agreement, the commission caused the general engineering consultant to make an inspection of the project on or before the 90th day prior to the end of the fiscal year and to submit a report to the commission. A copy of the report shall be filed with the trustee.*

(4) **Travis and Williamson Counties**

Voluntary Quarterly Report of Actual Traffic and Toll Revenue for the Central Texas Turnpike System ([Report](#))

*The commission financed a portion of the costs of the system with obligations issued pursuant to a trust indenture. In accordance with Section 501 (c) of the trust indenture, the commission covenants that for the first five full years of operation of the system, the commission will provide to the trustee a report showing the traffic and revenue of the system for the previous quarter. The commission may discontinue the reports because the revenues for the previous two years have been sufficient to meet the rate covenant; however, the commission has not exercised its option to discontinue the reports. A copy of the report is being filed with the trustee and the Municipal Securities Rulemaking Board through its Electronic Municipal Markets Access System.*

(5) **Grimes and Montgomery Counties**

Quarterly Traffic and Revenue Report for the SH 249 System ([Report](#))

*The commission financed a portion of the costs of the system with obligations issued pursuant to a trust agreement. In accordance with Section 709 of the trust agreement, the commission is providing to the trustee, general engineering consultant, and traffic consultant a report of general information regarding the system for the preceding fiscal quarter. A copy of the report is being filed with the Municipal Securities Rulemaking Board through its Electronic Municipal Markets Access System.*

(6) **Quarterly Investment Report**

Quarterly Investment Report for all of the funds invested at the direction of the commission ([Report](#))

*This is a presentation of the quarterly investment report for the investment of: (1) funds held by the Bank of New York Mellon, as trustee, under the Indenture of Trust securing the Central Texas Turnpike System toll revenue obligations; (2) funds for the pre-paid TxTag account held by the Bank of New York Mellon, acting as custodian; (3) funds held by Amegy Bank, a Division of ZB, National Association, as trustee, under the Trust Agreement securing the I-35E Managed Lanes Project toll revenue obligations; and (4) funds held by U.S. Bank National Association, as trustee, under the Master Trust Agreement securing the SH 249 System toll revenue obligations.*

(2) **Investment Policy and Investment Strategies**

Consider the annual review and approval of the investment policy and investment strategies applicable to all funds of the commission not otherwise required to be invested by the comptroller ([MO](#))

*This minute order approves the commission's investment policy and investment strategies. The Public Funds Investment Act requires the commission to review the investment policy and investment strategies on an annual basis, and to approve by order any modifications to the investment policy and investment strategies.*

(3) **Travis and Williamson Counties**

Consider the approval of the Central Texas Turnpike System annual operating, maintenance and capital budgets ([MO](#))

*This minute order approves the annual operating, maintenance, and capital budgets for the Central Texas Turnpike System (CTTS) which consists of SH 130 Segments 1-4, SH 45N, SH 45SE, and Loop 1 extension. Some costs of the CTTS were financed with debt obligations. The Indenture of Trust stipulates that the commission will adopt annual budgets by August 31 of the preceding fiscal year.*

Consider the adoption of the SH 249 System annual budget of revenues, operating and maintenance expenses, major maintenance expenditures, and capital expenditures ([MO](#))

*This minute order adopts the annual budget of revenues, operating and maintenance expenses, major maintenance expenditures, and capital expenditures for the SH 249 System (system). The commission financed a portion of the costs of the system with obligations issued pursuant to a trust agreement. The trust agreement stipulates that the commission on or before the end of each fiscal year (or such other date as is consistent with the commission's policies then in effect) will adopt an annual budget for the system.*

(5) **Dallas and Denton Counties**

Consider the approval of the I-35E Managed Lanes Project annual budget of revenues, operating and maintenance expenses, and capital expenditures ([MO](#))

*This minute order approves the annual budget of revenues, operating and maintenance expenses, and capital expenditures for the I-35E Managed Lanes Project in Dallas and Denton counties. The commission financed a portion of the costs of the I-35E project with a Transportation Infrastructure Finance and Innovation Act loan. The trust agreement for the loan stipulates that the commission will adopt an annual budget by the business day preceding the first day of each fiscal year.*

*The department has established a separate fund to account for and track projects and project costs funded with the SH 121 payments. This minute order authorizes the funding of additional project costs and changes to the list of previously approved projects. The project costs to be funded were selected through a cooperative process with the Regional Transportation Council.*

f. **Highway Designation**

**Kaufman County** - In the city of Crandall, consider redesignating a segment of FM 148 as FM Spur 148, designating a segment of FM 148 on a new location, designating a segment of FM 148 concurrently with US 175, and redesignating a segment of FM 148 as FM 3039 ([MO](#))

*This minute order: (1) redesignates a segment of FM 148 as FM Spur 148 from the intersection of US 175 southward through the city of Crandall to the intersection of FM 3039, a distance of approximately 0.5 miles; (2) designates a segment of FM 148 on a new location from the intersection of US 175 south and southeastward to the intersection of existing FM 148, a distance of approximately 1.6 miles; (3) designates a segment of FM 148 concurrent with US 175 from the intersection of existing FM 148 eastward to the intersection of the proposed new location of FM 148, a distance of approximately 1.2 miles; and, (4) redesignates a segment of FM 148 as FM 3039 from the intersection of existing FM 3039 and existing FM 148, southeastward to the intersection of existing FM 148 and proposed new FM 148, a distance of approximately 1.8 miles.*

**Various Counties** - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state ([MO](#))

*This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*
