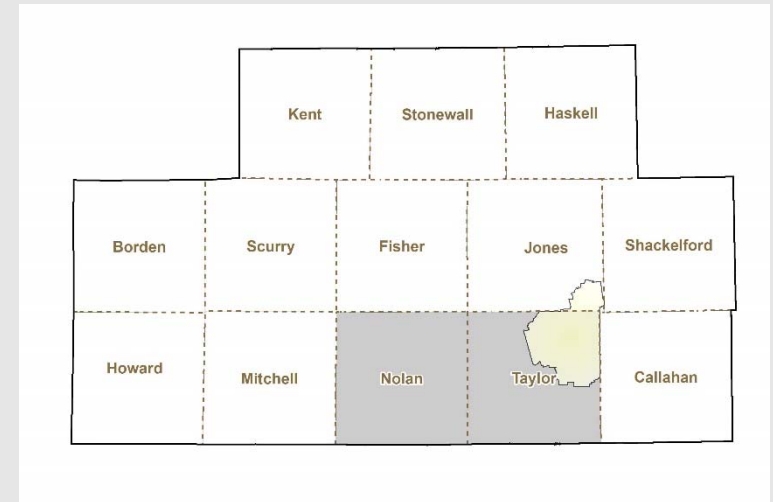

 - Taylor



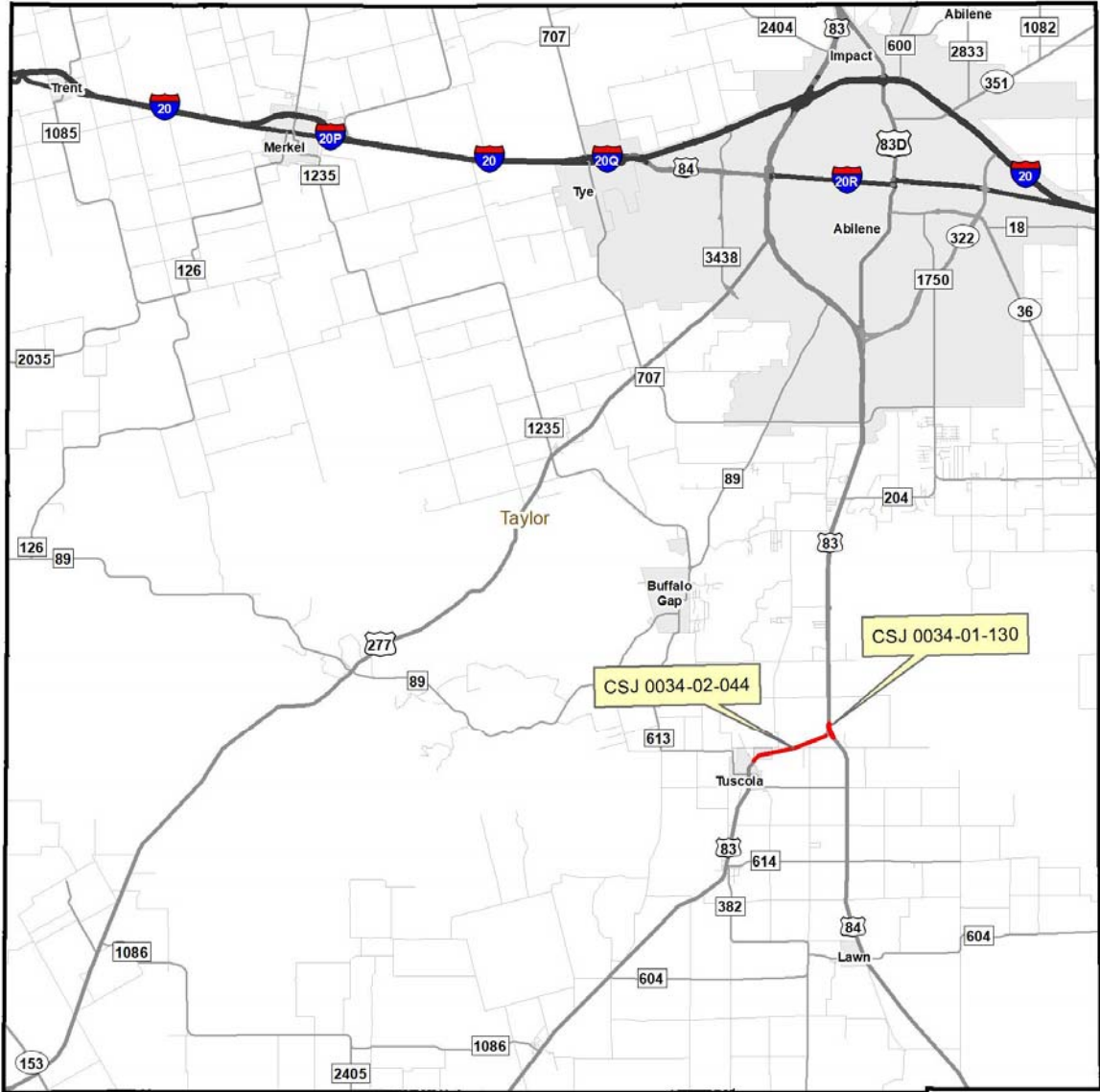

Why is the Rural TIP being revised?

- TxDOT Districts submitted Rural TIP projects to the Statewide Transportation Improvement Program (STIP) for input.
- Upon review, fiscal changes will affect the original projects.
- Changes or constraints can result in:
 - Rescheduling the timeline
 - Putting project on hold
- As part of ongoing public involvement, TxDOT is providing the Rural TIP changes for public comment.

The following slides will highlight the projects and schedules that will be affected by the 2021-2024 Rural TIP Revision for the Abilene District.

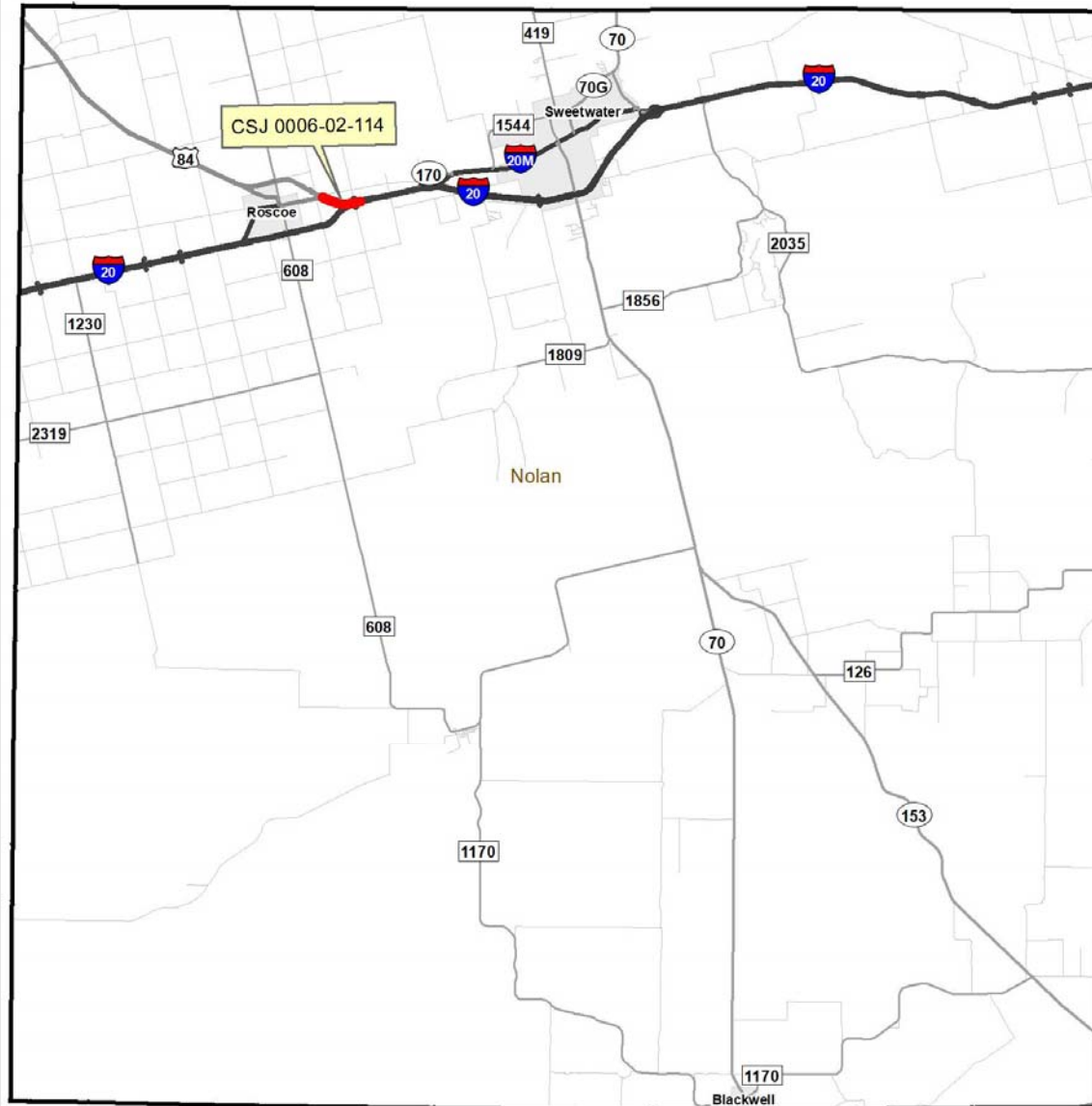

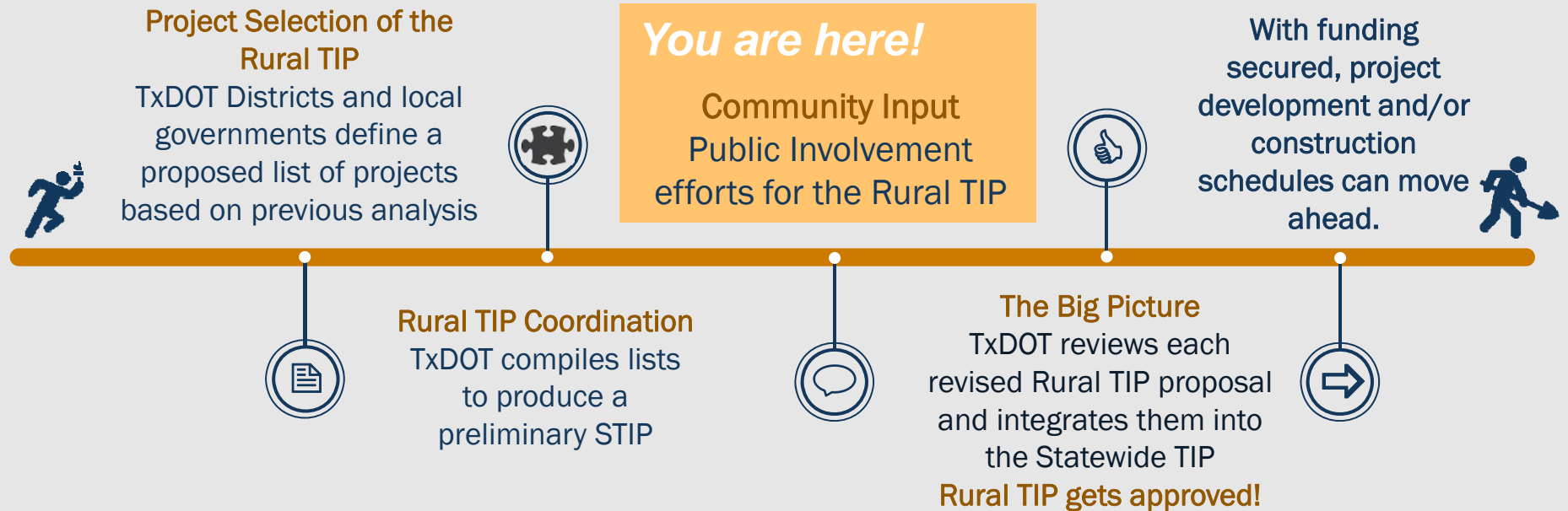
