



## Notice of Virtual Public Meeting Texas Department of Transportation 2023–2026 Rural Transportation Improvement Program August 2023 Revision ATLANTA DISTRICT

The Texas Department of Transportation (TxDOT) – Atlanta District will conduct an online virtual public meeting for the 2023–2026 Rural Transportation Improvement Program (Rural TIP) August 2023 Revision which includes projects in Bowie, Harrison, and Upshur counties. The Atlanta District includes Bowie, Camp, Cass, Harrison, Marion, Morris, Panola, Titus, and Upshur counties. The Rural TIP includes all added capacity and regionally significant projects to be funded within a TxDOT District during the next four years, including those eligible for federal funding. As such, this meeting offers the public an opportunity to review and comment on the proposed priorities. The Rural TIP Revision is the first step on the road to revising the Statewide Transportation Improvement Program (STIP).
