Notice of Virtual Public Meeting Texas Department of Transportation Available for Viewing on Friday, Dec. 16, 2022 by 12 p.m. 2023– 2026 Rural Transportation Improvement Program (Rural TIP) Revision Atlanta District

The Texas Department of Transportation (TxDOT) will be conducting a virtual public meeting for the proposed 2023--2026 Rural Transportation Improvement Program (Rural TIP) Revision for the Atlanta TxDOT District.

The virtual public meeting pre-recorded presentation will be available for viewing on Friday, Dec. 16, 2022 by 12 p.m. This virtual meeting format (no in-person meeting) includes a pre-recorded video presentation and comment opportunity. The presentation will include both audio and visual components.

The purpose of this virtual public meeting is to receive comments on the proposed revision to the projects that were approved in the 2023-2026 Rural TIP, which was presented on May 9, 2022. On that date, the Atlanta TxDOT District presented the proposed 2023-2026 Rural TIP for its nine counties. The Atlanta District includes Bowie, Cass, Marion, Harrison, Panola, Titus, Morris, Camp, and Upshur counties.

The project listed in the approved 2023-2026 Rural TIP and proposed to be removed from the TIP in the November 2022 Revision:

CSJ 1575-05-016, SL 390 in Harrison County (From 0.7 Mi N of US 80 to 1.2 Mi S of IH 20)

The projects proposed to be added to the 2023-2026 Rural TIP in the November 2022 Revision:

CSJ 1575-05-024, SL 390 in Harrison County (From 0.7 Mi N of US 80 to IH 20)

CSJ 0495-09-065, IH 20 in Harrison County (From Five Notch Road to FM 31)

The Rural TIP includes all regionally significant projects to be funded within a TxDOT District during the next four years, including those eligible for funding. As such, this meeting will offer the public an opportunity to review and comment on the proposed revision.

The 2023-2026 Rural TIP Revision meeting is being held pursuant to *Title 43, Texas Administrative Code, Section 16.102*, which calls for an opportunity for public comment concerning the program. Presentation materials will show the project being proposed to be revised from the previously proposed Rural TIP and modification.

The RTIP Revision Virtual Public Meeting will be conducted in English. If you need an interpreter or document translator because English is not your primary language or if you have difficulty communicating effectively in English, one will be provided to you. If you have a disability and need assistance, special arrangements can be made to accommodate most needs.
