Why is the Rural TIP being revised?

- TxDOT Districts submitted Rural TIP projects to the Statewide Transportation Improvement Program (STIP) for input
- Upon review, fiscal changes will effect the original projects
- Changes or constraints can result in:
 - Rescheduling the project development timeline
 - Putting a project on hold
- As part of ongoing public involvement, TxDOT is providing the Rural TIP changes for public comment.

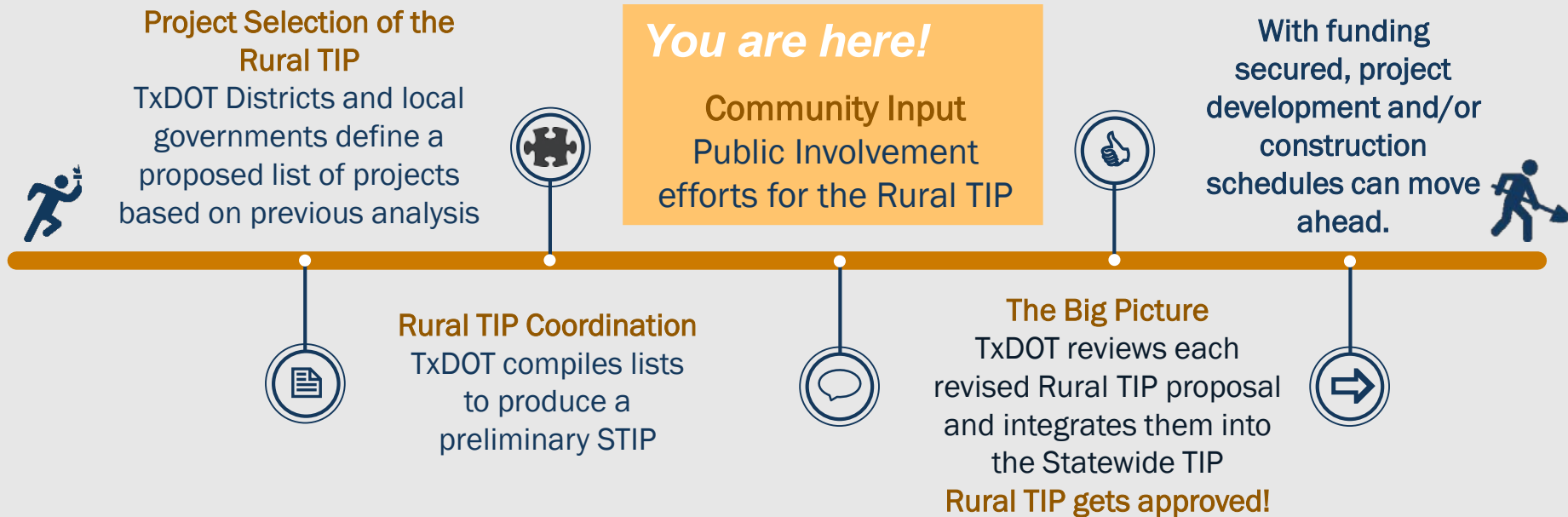
