### **Finding of No Significant Impact Available for Public Review**

#### **SH 63/ LA 8**

#### **From Sabine River Texas Side to Sabine River Louisiana Side**

**CSJ(s): 0214-03-035, 0214-03-037, 0214-03-032, and 0214-03-040**

#### **Newton County, Texas and Vernon Parish, LA**

This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a finding of no significant impact (FONSI) for the proposed SH 63 at Sabine River Bridge - Main, and that the FONSI is available for public review. The proposed project would replace and widen the existing bridge from 0.16 mile west of CR 2119. to 1.35 miles east of the proposed bridge and ties in at LA 111. in Newton County, Texas and Vernon Parish, LA.

The FONSI and approved final environmental assessment (EA) are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at TXDOT-Beaumont District, 8350 Eastex Fwy, Beaumont, TX 77708, 409-892-7311.
