

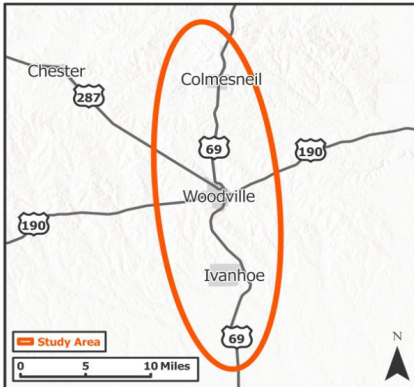
YOU'RE INVITED!

US 69 WOODVILLE-COLMESNEIL RELIEF ROUTE PUBLIC MEETING

The TxDOT Beaumont District will host a virtual public meeting with in-person options to gather input on the modified relief route alternatives for US 69 from approximately one mile south of Black Creek to one mile south of Recreational Road (RR) 255 in Tyler County. US 69 is a south-north highway that runs from Port Arthur to Denison, TX and is designated as a hurricane evacuation route.

Based on public input received during the October 2023 public meetings, TxDOT is presenting two modified relief route alternatives for public review and input.

All interested community members are invited to attend this public meeting. The public meeting will be conducted in English. The virtual meeting will consist of a pre-recorded video presentation including both audio and visual components. In-person attendees will be able to view the same presentation delivered in the virtual public meeting, review hard copies of project materials, and ask questions of TxDOT staff and/or consultants. This will be a come and go event and no formal presentation can be held."
