### Finding of No Significant Impact Available for Public Review

### FM 70/SH 286 PASSING LANES

FM 70 from SH 286 to US 77 and on SH 286 from south of FM 2444 to FM 70

This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a finding of no significant impact (FONSI) for the proposed FM 70/SH 286 Passing Lanes, and that the FONSI is available for public review. The proposed project would construct passing lanes and widen shoulders on Farm to Market (FM) 70 from State Highway (SH) 286 to U.S. Highway (US) 77, and on SH 286 from south of FM 2444 to FM 70 in Nueces County, Texas.

The FONSI and approved final environmental assessment (EA) are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the Corpus Christi District Office at 1701 S.
