



Notice of Availability for Finding of No Significant Impact (FONSI)

US 77 WOODSBORO-REFUGIO IMPROVEMENT PROJECT

From south of Woodsboro to north of Refugio | Refugio County, Texas

This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a finding of no significant impact (FONSI) for the proposed US 77 Woodsboro-Refugio Improvement Project and that the FONSI is available for public review. The project would upgrade the corridor as part of the future development of Interstate 69 (I-69) to meet interstate standards. This includes upgrading existing and new location facilities to a 4-lane divided freeway with controlled access (exit/entrance ramps and overpasses). The proposed project would extend for a total of approximately 13 miles, beginning just south of Woodsboro and ending approximately 3 miles north of Refugio.

The approved FONSI and final Environmental Assessment (EA) are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the TxDOT Corpus Christi District Office, 1701 S. Padre Island Dr., Corpus Christi, TX 78416. They are also available online at www.txdot.gov, keyword search: "Woodsboro Refugio FONSI".
