The Texas Department of Transportation's (TxDOT) Corpus Christi District, in coordination with Refugio County, is continuing the project development process for the US 77 Woodsboro Refugio Improvement Project. TxDOT's Corpus Christi District is proposing to upgrade the existing US 77 corridor near Woodsboro to interstate standards and construct a new US 77 roadway to interstate standards east of the City of Refugio. US 183 would also be extended to connect to the new US 77 roadway. This notice advises the public that TxDOT is conducting an online open house on the proposed project with two in-person options.

In-person attendees will be able to view the same presentation delivered in the online open house playing on a screen, review hard copies of project materials, ask questions of TxDOT staff and/or consultants, and leave written comments.
