**Finding of No Significant Impact
Available for Public Review**

FM 1387

From North Midlothian Parkway to FM 664

CSJs: CSJs 1394-02-027 and 1394-01-002

Ellis County, Texas

This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a finding of no significant impact (FONSI) for the proposed Farm-to-Market Road (FM) 1387, and that the FONSI is available for public review. The proposed project would reconstruct, widen, and realign FM 1387 from North Midlothian Parkway to FM 664 in Ellis County, Texas.

The FONSI and approved final environmental assessment (EA) are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the TxDOT Dallas District Office at 4777 East US Highway 80, Mesquite, TX 75150-6643; (214) 320-6675.
