The El Paso District includes El Paso County, Hudspeth County, Culberson County, Jeff Davis County, Presidio County, and Brewster County. The Rural TIP includes all added capacity and regionally significant projects to be funded within a TxDOT District during the next four years, including those eligible for federal funding.
