The city of Lubbock in partnership with the Texas Department of Transportation (TxDOT) are proposing to widen 114th Street from Quaker Avenue to Indiana Avenue in Lubbock County, Texas. This notice advises the public that the city of Lubbock will be conducting a virtual public meeting on the proposed project.
