



Notice of an Open House

Spur 421 (Bandera Road) from Evers Road to Cincinnati Avenue

The Texas Department of Transportation (TxDOT) is proposing improvements to Spur 421 (Bandera Road) from Evers Road to Cincinnati Avenue in Bexar County, Texas. This notice advises the public that TxDOT will be conducting an open house on the proposed project.

TxDOT is providing an Open House where attendees will be able to review hard copies of project materials, ask questions of TxDOT staff and/or consultants and leave written comments. **The open house will be held on Tuesday, July 23, from 5 to 7 p.m. at St. Paul's Community Center, 1201 Donaldson Ave, San Antonio, TX 78228.**

Meeting materials will be available online from Tuesday, July 23 to Wednesday, August 7. To view the open house materials online, go to the following web address at the date and time indicated above: **www.txdot.gov, keyword search "Spur 421 (Bandera)."** If you do not have internet access, you may call (210) 463-4402 between the hours of 8 a.m. and 5 p.m. Monday through Friday to ask questions and access project materials during the project development process.

TxDOT is proposing improvements to Spur 421 (Bandera Road) from Evers Road to Cincinnati Avenue in San Antonio, Bexar County, a length of approximately three miles. The purpose of the proposed project is to improve safety for vehicular traffic and reduce the conflict points where crashes are most likely to happen. The roadway today consists of three through lanes in each direction with a two-way center left turn lane. TxDOT proposes to add a new raised center median along the corridor with directional median openings at select locations. All improvements would be constructed within the existing right of way.

Any maps and drawings showing the project location and design, tentative construction schedules and other information regarding the proposed project are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the TxDOT San Antonio District Office located at 4615 NW Loop 410, San Antonio, TX 78229-0928. The San Antonio District office phone number is (210) 615-5839. Project materials are also available online at www.txdot.gov, keyword search "Spur 421 (Bandera)." These materials will also be available in hard copy form for review by those attending the open house in person.

The open house will be conducted in English. If you need an interpreter or document translator because English is not your primary language or you have difficulty communicating effectively in English, one will be provided to you. If you have a disability and need assistance, special arrangements can be made to accommodate most needs.
