The Texas Department of Transportation (TxDOT) Tyler District will conduct a virtual public meeting to include a pre-recorded presentation containing both audio and visual components on Tuesday, Dec. 14, 2021. The virtual meeting will be available online beginning at 4 p.m. at www.txdot.gov, keyword search: Tyler District 2021 Virtual Annual Bicycle Meeting.

The purpose of this meeting is to provide information regarding transportation projects and programs that might affect bicycle use on the state system within the Tyler District. The Tyler District is made up of Anderson, Cherokee, Gregg, Henderson, Rusk, Smith, Van Zandt, and Wood counties. A presentation showing bicycle and pedestrian roadway accommodations will be shown during the virtual meeting, and the public will have the chance to provide written comments by mail or email.

In the event such request is received, the public meeting to be held Tuesday, Dec. 14, 2021, will be rescheduled as a formal public hearing.
