**In-Person Open House with Virtual Option**  
**US 77 LA GRANGE FEASIBILITY STUDY**

**Fayette County, Texas**

US 77 serves as a freight corridor within the Texas Highway Freight Network connecting people and goods locally and throughout Texas. The Texas Department of Transportation (TxDOT) is conducting a feasibility study to identify and evaluate potential improvements to US 77 in Fayette County to address safety concerns related to truck traffic along the corridor. Goals of the feasibility study include reducing truck-related crashes and improving mobility for local and through traffic. This study focuses on the segment of the roadway that passes through the City of La Grange.

This notice advises the public that TxDOT is hosting an in-person open house with a virtual option to share preliminary alignment alternatives for a relief route for US 77 in Fayette County.

**The in-person open house will be held from 4:30 p.m. to 6:30 p.m. on Thursday, Oct. 5, 2023 at VFW Hall, 500 Veterans Memorial Drive, La Grange, TX 78945.** In-person participants are welcome to come and go any time from 4:30 to 6:30 p.m. and will be able to review project materials, ask questions of TxDOT staff and/or consultants, and leave written comments.

**The virtual open house will consist of a pre-recorded video presentation and will include both audio and visual components.** The virtual open house is **not** a live broadcast event and can be viewed online starting at 4:30 p.m. on Thursday, Oct. 5, 2023, and will remain available for viewing at the web address indicated below through Friday, Oct. 20, 2023. The purpose of the study is to identify and evaluate potential improvements to US 77 to address safety along the corridor.

The in-person open house will be conducted in English. Project materials will be available in English and Spanish for both meeting formats. If you need an interpreter or document translator because English is not your primary language or you have difficulty communicating effectively in English, one will be provided to you. If you have a disability and need assistance, special arrangements can be made to accommodate most needs. If you need interpretation or translation services or you are a person with a disability who requires an accommodation to attend and participate in the in-person or virtual open house, please contact the US 77 Project Team at (979) 250-5086 no later than 4 p.m., Friday, Sept. 29, 2023. Please be aware that advance notice is required as some services and accommodations may require time for the Texas Department of Transportation to arrange.
